### Uniserve reports results for fiscal year ended May 31, 2024

**Vancouver, BC: September 27, 2024 – Uniserve Communications Corporation** (the “Company” or “Uniserve”)(TSXV: USS) a provider of IT solutions and services to business and residential customers in Canada wishes to announce its annual fiscal 2024 financial results. Revenues for fiscal 2024 were \$6,439K as compared to \$6,536K for the prior fiscal year. The annual fiscal 2024 Operating Loss was \$239K compared to an Operating Loss of \$2K for the prior fiscal year. Net loss for fiscal 2024 was \$191K as compared to Net Income of \$14K for the prior fiscal year.
